**CIRCULAR**

**Sub: PALAMURU UNIVERSITY - UNIVERSITY TEACHERS** — UGC Regulations — 2010 / 2018 — Career Advancement Scheme — Applications called for - Exercising option for UGC 4th Amendment — UGC Regulations-2018 — Circular — Issued.

The University Grants Commission (UGC), New Delhi through its notification vide reference 5th cited issued an amendment in the UGC Regulations-2018. This may be called the University Grants Commission (Minimum Qualifications for Appointment of Teachers and other Academic Staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education) (4th Amendment) Regulations, 2024, (UIN:2/2024)” and the same is adopted in toto by the University.

In the 4th amendment, Clause 6.3 of UGC Regulations-2018 amended as follows:

The criteria for promotions under the Career Advancement Scheme laid down under these Regulations shall be effective from the date of notification of these Regulations. **However, to avoid hardship to those faculty members who have already qualified or are likely to qualify till 31st December 2024** as per the UGC Regulations on Minimum Qualifications for Appointment of Teachers and other Academic staff in Universities and Colleges and other Measures for the Maintenance of Standards in Higher Education, 2010, **a choice may be given to them either for being considered for promotions under the 2010 or 2018 Regulations.** The date of eligibility shall be retained as the date of promotion. On the date of submission of the application, the candidate should fulfil all the eligibility criteria required for promotion.”

In view of the amended provision of Rule / Clause 6.3 as mentioned above, applications in the prescribed proforma (in duplicate) are invited from the internal eligible teachers who fulfil the eligibility conditions as on **31.12.2024** as per CAS of UGC Regulations-2010 or UGC Regulations-2018 for movement to next higher levels, which are as under:

- i) Assistant Professor Academic Level—11, Pay Band of Rs.68,900 — 2,05,500/- (Assistant Professor Rs.15,600-39,100+AGP Rs.7,000/-)
- ii) Assistant Professor Academic Level — 12, Pay Band of Rs.79,800 — 2,11,500/- (Assistant Professor Rs.15,600-39,100+AGP Rs.8,000/-)
- iii) Associate Professor Academic Level — 13A, Pay Band of Rs.1,31,400 - 2,17,100/- (Associate Professor Rs.37,400-67,000+AGP Rs.9,000/-)
- iv) Professor Academic Level - 14, Pay Band of Rs.1,44,200 - 2,18,200/- (Professor Rs.37,400-67,000+AGP Rs.10,000/-)
- v) Senior Professor Academic Level-15, Pay Band of Rs.1,82,200-2,24,100 (UGC RSP-2016)

The eligible teachers need to exercise only one option and submit option form for upgradation / Promotion either as per UGC Regulations-2010 or UGC Regulations-2018. Separate option forms are provided for UGC Regulations-2010 (UGC RSP-2006) and UGC Regulations-2018 (UGC RSP-2016).

The CAS application form of UGC Regulations-2010 and UGC Regulations-2018, Option form along with UGC 4th Amendment can be downloaded from the University website **[www.palamuruuniversity.ac.in](http://www.palamuruuniversity.ac.in)**.

The filled-in application in the prescribed Proforma (in duplicate) and its soft copy through e-mail to [registrarputg@gmail.com](mailto:registrarputg@gmail.com) should be submitted on or before **04-04-2025** along with payment receipt of application fee of Rs.5,000/- to be remitted through online mode to the Registrar, Palamuru University.
