Telangana Public Service Commission has scheduled the Group II Examination on 7th and 8th August, 2024. These exams were announced well in advance keeping in view of other pre fixed competitive exams at national and state level like UPSC, SSC, IBPS & other recruitment boards.

There is a requirement of adequate number of test centres as over 5.5 lakh applicants are expected to appear for the Group II Exam.
