Under any circumstances cash/DD will not be accepted.

You are therefore, requested to submit the filled in application form with all the necessary original documents along with an attested copy as mentioned in the annexure without fail **before 30-04-2025** along with remittance slip and AISHE –DCF –II (2024-25) **UPLOADED CERTIFICATE.**
